Terms and Limitations of the In-House Plan

- This is a dental discount plan and is NOT dental insurance. It cannot be combined with any other dental insurance.
- The effective date of this plan is the day you sign the agreement. And it is in effect for one year after the agreement date.
- Exams, radiographs, prophylaxis, and fluoride must be performed within the year of enrollment and cannot be carried over to the next year.
- Payment is due at the time of service for any work not covered 100% by this plan.
- This plan is only accepted at Johnson Family Dental. Therefore, if you are referred to a specialist, they will NOT offer these discounts.
- Should there be dental treatment needed following any type of injury where a lawsuit, and therefore outside medical, care, disability, or workers comp type insurances are involved, this discount plan cannot be used.
- This plan is non-transferable. Family members cannot be substitutes for another family member.
- Membership benefits are not transferable, have no cash value and may not be redeemed for cash.
- Total payment amount is due at the time services are provided. If full payment is not received at the time of service, the discount fee will be VOID.
